RESTRICTIVE COVENANTS

AGAINST LOTS IN ROOFF'S ADDITION IN WATERLOO, IOWA

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES, the said John Rooff

for himself and grantees, administrators, executors, successors and assigns, hereby covenants that all of the lots in said addition shall be and are hereby restricted as to their use and occupancy in the manner hereinafter set forth so far as the same shall apply to each particular lot,

NOW, THEREFORE, all persons and corporations who now own or shall hereinafter acquire any right, title or interest in said lots and with their or its successors and assigns, shall be taken and held to agree and covenant with the owners of the lots shown on said plat to conform to and observe the following covenants, restrictions and stipulations as to the use and occupancy thereof and the construction of residences and improvements thereon for a period of 25 years from the date of the filing of the said plat.

NOW, THEREFORE, the restrictions hereinbefore referred to shall be as follows, to-wit:

- L. There shall be reserved for use of public utilities an easement of four (4) feet to the rear of each lot for the construction, maintenance and development of utility improvements.
- 2. No person other than a member of the Caucasian race shall own, rent, lease or occupy any of the property covered by this plat.
- 3. No outdoor toilets shall be permitted on any lot when sanitary sewage is available or when material, labor and outlets are readily accessible for cesspools.
- 4. Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.
