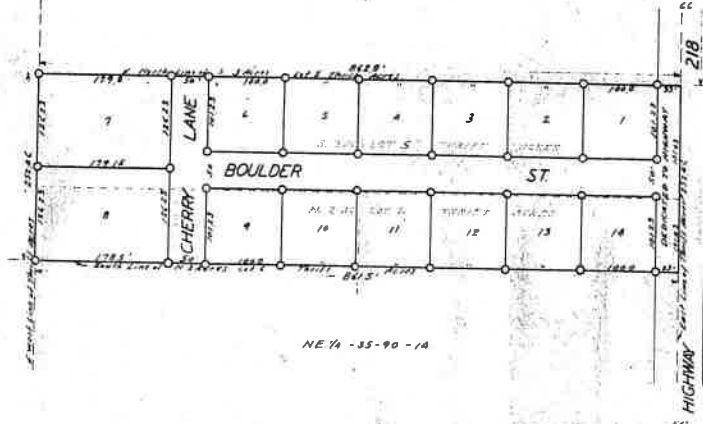


BEL AIR ADDITION
