

<p><b>OWNER'S CERTIFICATE</b></p> <p>I, MORTHA M. ADIN, being single and unmarried and being deceased, of Waterloo, Iowa, do hereby certify by these presents that the premises set apart the premises described in the attached description of M. R. Schenck, professional civil engineer and land surveyor, and as set out in the accompanying plat, are the same as the premises described in the ADDITION IN THE CITY OF WATERLOO, Black Hawk County, Iowa, with free covenants and in accordance with the desire of the undersigned owner of said property.</p> <p>Said premises are platted subject to the following reservations which shall run with the land and shall be binding upon all persons using, owning or occupying the same:</p> <p>1a. No buildings other than private dwelling houses, together with unincorporated outbuildings, shall be erected upon this property, and the property shall not be used or occupied for other than residential purposes.</p> <p>2a. No old or previously used buildings shall be moved upon the premises and no mobile trailers shall be erected thereon.</p> <p>3a. No part of said premises shall be used as a trailer camp nor shall any trailer, garage or temporary structure be used as temporary or permanent living quarters.</p> <p>4a. No part of the premises herein platted shall be sold, leased to, given or otherwise disposed of to persons other than members of the German Race, excepting that the provisions shall not apply to servants of the owners or tenants.</p> <p>The above restrictions shall run with the land and shall be in effect for a period of twenty-five years from and after the date of filing of this plat and a violation of any of the restrictions shall not work a forfeiture but may be enjoined in a suitable action by any owner of real estate in said plat who is directly affected.</p> <p>There shall be reserved an easement across Lots Nos. 1, 2 and 4 as shown on the attached engineer's plat, for the construction, maintenance, development and repair of sewer, water, gas, electricity and telephone services.</p> <p>Dated this / day of July 1949.</p> <p><i>Mortha M.
